- President Hollande begins a three-day-long official visit in the United States
- Bertrand Delanoë, the outgoing mayor of Paris presides over his last City Council
- Justice Minister Christiane Taubira meets prosecutors in Paris
- The Socialist Party organizes a seminar about the economic agenda of the President
- Taxi drivers to go on strike in Paris
